1. The Person / Persons is/ included account of the land after the acceptance of his application form, Registry after deposited full payment.
2. Installment will be deposited under schedule of the scheme as under

3. Fully Developed form / villa/plot/fat will be allotted by company.
4. Installment date is 15<sup>th</sup> of every calendar month.
5. If the payment is late after due date interest will be charged at 1% per annum.
6. Purchaser is free to transfer his/ her property to another person, company will charge 1% per transferable charge.
7. In case of continuous default in making payments of installment for 1 month by the purchaser, then applicants will be considered as a defaulter and form /villal plot/fat shall be cancelled forthwith without any intimation in writing and only 50% of remaining amount is refundable in fifteen (15) working days of submitted applications.
8. The company reserves the right to allot the plots cancelled due to default to any other prospective purchaser.
9. In case of any increase or decrease in the plot area as per sanctioned authority the same shall be binding upon the purchaser and accordingly the purchaser shall be liable to pay of the booking rate towards the increase in the area and in case of decrease the company shall proportionately refund the purchaser difference amount. No complaint will be entertained in this respect by the company.
10. The purchaser can purchase the plot in joint names, but the correspondence will be carried out with any one of the purchaser. The purchaser can also appoint nominee on their behalf.
11. In case of any change in the postal address of the purchaser he/she must inform his/her new address to the company immediately in writing.
12. The buyer is allowed for correspondence with the company on its office address only. That in case of any dispute, the decision of the company will be final and it will always be subject to business jurisdiction only.
13. The Buyer Should obtain the valid receipt from the office on payment.
14. It is the duty of the every buyer to visit the company's office personally or through authorized person and keep themselves updated in regard to his/ her form/plot/villa/fat and the payments of agreed monthly installments.
